Background and study purpose

The Minnesota Department of Natural Resources (MNDNR) periodically conducts assessments of stakeholders' values, beliefs, attitudes, and behaviors pertinent to the natural resources it is entrusted to manage. In this this study, we surveyed 2022 wild rice license holders to better understand their:

- 1) Participation in wild rice harvesting, and size of harvest;
- 2) Locations of wild rice harvest;
- 3) Timing of wild rice harvest;
- 4) Encounters and perceptions of conflict with waterfowl hunters;
- 5) Satisfaction with wild rice harvesting;
- 6) Perception of crowding;
- 7) Motivations for wild rice harvesting, and
- 8) Constraints to wild rice harvesting

Methods

Sampling and data collection

DNR Wildlife staff (we) conducted a census of all 2022 wild rice license holders (n = 1,532) aged 18 and over at the time of survey administration (October 1, 2022). We solicited responses using a repeat mail design with three points of contact. Each participant received a letter describing the study purpose, a questionnaire, and a postage-paid self-addressed return envelope (survey packet) at each contact. Non-respondents received a second and/or third survey packet roughly 3 weeks after the previous packet. Data collection ceased mid-December 2022.

Results of this study are representative of Minnesota Department of Natural Resources wild rice license holders. Tribal governments regulate the gathering of wild rice (*manoomin*) on their sovereign lands. Since 2016, members of Minnesota Tribes can harvest wild rice in Minnesota without needing a state harvesting license.

Response rate

We removed 89 individuals from the population owing to incomplete or inaccurate contact information. Data collection efforts results in 841 responses for an adjusted response rate of 58% (Table 1).

Weighting

We weighted results according to proportional representation of respondents versus the population of wild rice license holders by age. Table 2 contains a summary of weights applied to the data to make representative estimates at the population level. We created four quartiles of age to calculate weights.

Summary of results

Participation and harvest

We asked respondents to report if they participated in harvesting wild rice during the 2022 season, how much rice they harvested, if they sold any rice they harvested, and how many days they spent harvesting wild rice during the season.

- Nearly all respondents (91%) indicated that they participated in wild rice harvesting in Minnesota during the 2022 season (Table 3).
- Of those that went ricing, the average reported harvest was 128 pounds per person (Table 4).
 We estimated a statewide harvest of 178,432 pounds of unprocessed wild rice.
- We estimated that 14% of wild rice harvesters sold rice that they harvested in 2022 (Table 5).
- On average, wild rice harvesters spent 2.8 days harvesting wild rice during the 2022 season. We estimated a total of 3,092 person days were spent harvesting wild rice in Minnesota in 2022 (Table 6).

Harvest location

We asked respondents to report their top 5 locations of harvest by waterbody, county, and nearest town, and the number of days they spent harvesting wild rice at that location. Figure 1 contains a depiction of the reported days spent harvesting wild rice in counties in Minnesota. These data are not an estimate of the population, but the raw number of days reported by survey respondents.

- Wild rice harvest effort was concentrated in the Northern half of the state (Figure 1).
- More than half (52%) of the days Minnesotans spent harvesting wild rice, as reported by survey respondents, occurred in Itasca, Cass, St. Louis, and Aitkin counties combined (Table 7).

Time and date of harvest

We asked respondents to report what days during the season they were active harvesting wild rice, and the time of day that they harvested wild rice during a "typical day" during the 2022 season.

- Harvesting effort peaked during the period September 3rd to September 7th, where greater than 50% of license holders reported going ricing (Figure 2). Very few license holders reported harvesting during the first and last days of the wild rice harvest season.
- More than 50% of wild rice harvesters reported that they were active harvesting wild rice during the entirety of the legal harvest day on a typical days, (Figure 3), and more than 80% reported harvesting between the hours of 10am and 12pm.

Experience and perceived conflict with waterfowl hunters

We asked wild rice license holders about their interactions with waterfowl hunters, whether or not those interactions negatively impacted their wild rice harvesting experience, perception of safety when encountering waterfowl hunters, and how they responded to encountering waterfowl hunters. Figure 4 contains a summary of estimates of the number of wild rice license holders that participated in the season, encountered waterfowl hunters, and perceived conflict from the encounter.

- Very few (5%) wild rice license holders reported that they avoided going ricing during the experimental early teal season in order to avoid waterfowl hunters (Table 10).
- Around a quarter (28%) of wild rice license holders reported that they encountered waterfowl hunters while they were harvesting wild rice in Minnesota in 2022 (Table 11). We estimated that 390 wild rice license holders encountered waterfowl hunters.
- Of the 28% of wild rice license holders that encountered waterfowl hunters while harvesting wild rice, 26% reported that encountering waterfowl hunters negatively impacted their experience (Table 12). We estimated that 101 wild rice harvesters encountering waterfowl hunters while ricing in 2022 perceived that the encounter negatively impacted their experience.
- Table 13 contains a summary of wild rice harvesters' responses to encountering waterfowl
 hunters. The majority of wild rice harvesters reported that they continued ricing as usual when
 they encountered waterfowl hunters. Some wild rice harvesters reported moving to another
 location in the waterbody. Very few rice harvesters quit ricing, moved to another waterbody, or
 decided that ricing was not important to them.







Figure 5. Percent of wild rice harvesters' who encountered waterfowl hunters while harvesting wild rice in 2022 agreement or disagreement with the statement: I felt unsafe encountering waterfowl hunters while harvesting wild rice in Minnesota in 2022.

- Harvesters reported their agreement with the statement "I felt unsafe when encountering
 waterfowl hunters while harvesting wild rice in Minnesota in 2022." The majority of
 respondents that encountered waterfowl hunters (57%) either strongly, moderately, or slightly
 disagreed with the statement, while slightly more than a third (34%) agreed (Figure 5 and Table
 14).

Satisfaction and crowding

We asked wild rice license holders about their overall satisfaction with ricing in Minnesota in 2022, and about their satisfaction with elements of the wild rice harvesting experience.

- Overall satisfaction with wild rice harvesting in Minnesota was very high. Three-quarters of respondents reported feeling either slightly, moderately, or very satisfied (Figure 6 and Table 15).
- Nearly 60% of wild rice harvesters reported satisfaction with elements of the wild rice harvest experience presented to them (Table 16).

Motivations

We asked respondents their agreement or disagreement with statements about why they go wild rice harvesting, including: to be outdoors; to gather food; to harvest rice to sell; to spend time with friends or family;

for relaxation; for challenge, and to maintain the ricing tradition. Figure 7 contains a summary of respondents' mean agreement/disagreement with motivation statements.


 Wild rice harvesters reported the strongest agreement with the statements "to be outdoors" and "to gather food" as motivations for participating in wild rice harvesting. Respondents, on average, disagreed that harvesting wild rice to sell was a motive for their participation (Table 17).


Constraints


We asked respondents how limiting certain elements of wild rice harvesting were to their participation, including: finding a processor; finding a buyer; knowing when to harvest; financial expense; knowing where to harvest; having proper equipment; physical challenge; finding a partner, and timing of the rice crop. Figure 8 contains a summary of respondents mean perceptions of constraint items.

- Wild rice harvesters, on average, reported that the timing of the rice crop and finding a rice
 processer were the most limiting factors to their participation, among those evaluated (Table
 18).
- On average, wild rice harvesters rated finding a buyer the least constraining element of their participation (Table 18).

Figure 1. Days spent harvesting wild rice by Minnesota county as reported by survey respondents




